

# Travel Aware drug smuggling assets

Toolkit for partners



### Background

#### **Background:**

The FCDO and NCA have noted a sharp increase in drug smuggling arrests among British Nationals (BNs), both abroad and in the UK. The majority of arrests are linked to cannabis originating from Thailand. This follows the decriminalisation of cannabis in Thailand in 2022.

There is a serious risk of coercion by organised crime groups to BNs. Several have been offered money in exchange for carrying bags through customs.

The following assets include cannabis-specific messaging, but also general anti-drug smuggling warnings.



#### Aims

#### The campaign's aims are:

- To increase awareness among British travellers of the varying penalties for drug smuggling abroad.
- To warn BNs of predation by organised crime groups (OCGs) seeking to exploit the naivety and vulnerability of travellers.

#### **Travel Aware campaign aims:**

- To reduce the number of preventable incidents involving British nationals abroad that require consular assistance. This reduces time and financial resource spent by the British Government.
- To drive users to GOV.UK's <u>foreign Travel Advice service</u> and other relevant GOV.UK pages



#### Who this toolkit is for

- This toolkit is for all posts and partners. It provides guidance on how you can promote awareness of the consequences of drug smuggling.
- As well as reducing consular cases, increasing awareness of the consequences of drug smuggling will protect the safety and security of British nationals abroad.



#### Audience

- The Thailand-specific asset is, of course, targeting British nationals travelling to, or through,
   Thailand.
- The rest of the assets are generic, so as to be used anywhere.
- A large proportion of our audience is young people and those who are uninformed or naïve about the potential severity of the penalties for smuggling drugs.



## Key messages

- Do not carry anything through customs for someone else.
- Do not carry cannabis through customs for someone else.
- Do not carry cannabis out of Thailand.
- Do not carry drugs through customs for someone else.




## Thailand-specific assets

As the majority of drug smuggling consular cases are driven by BNs smuggling cannabis out of Thailand, this asset is location and drug specific.

This is available in 2 dimensions: square and vertical.

## General drug assets

We have 3 static assets relating to general drug smuggling (i.e. non-location specific).

One mentions cannabis, another 'drugs', and another 'anything', to cover all bases.

Designs are available in 2 dimensions each: square and vertical.




